**SASS RELEASE AND AUTHORIZATION**

Per the lease agreement between SASS and Carnation Farms, as a prerequisite to use of the Carnation Farm property, each SASS member shall submit to a background check. The background check will be conducted by Carnation Farms and the cost of the background check shall be borne by the person requesting access.
